TOURNAMENT REGULATIONS

1. USTA rules and code of ethics shall govern play.
2. All matches will be best 2 of 3 sets.
3. The 12 point tie-breaker and no-add scoring will be used at the discretion of the Tourn. Dir. (TD).
4. Players are responsible for checking on starting times and reporting to the tournament desk 30 minutes prior to scheduled first round playing time and 15 minutes for all other match times. Late players may be defaulted 15 minutes after scheduled match time.
5. The TD reserves the right to eliminate any player from the tournament for unbecoming conduct, on or off the court.
6. All players must show USTA card at check-in.
7. Singles and doubles, consolation rounds weather permitting.
8. Tournament committee reserves the right to round robin, combine or cancel events with less than three entrants or teams.
9. Allow time to register before first match.
